This Architectural Review package contains an Architectural Change Request Form, Indemnity Agreement, Paint Scheme Sheet, and instructions.

Any and all painting to your property must be submitted to the Architectural Review Committee (ARC) for review and approval **prior** to commencement of work.

The following details the procedure for submitting improvements for review by the Architectural Review Committee:

Submit one (1) completed copy of the Architectural Change Request Form, Indemnity Agreement, and Paint Scheme Sheet to:

Please include a \$50.00 review fee with your application/request form for landscape renovations in the front or backyard as well as for any large component installations such as, but not limited to, a pool/spa or patio cover.

Payment should be made out to Coventry Homes at Anthem Association. Payment must be in the form of a check or money order and there should be a memo indicating the payment is for "ARC Review Fee"

Please make sure the following submittal requirements have been met:

- Homeowner's Association fees are paid and current
- No liens and/or fines are owed to the Association
- Re-submittals require the inclusion of the previous submittal.
- Homeowner must comply and obtain all applicable city and county law permits.

Paint Scheme Sheet Requirements:

Your application must include the paint scheme being used and the location that each color will be applied. You may only select color schemes from the list of approved Coventry paint schemes located in our color books. Coventry paint scheme books may be viewed at either Dunn Edwards or Sherwin William's paint stores on S. Eastern Ave.

If repainting your home, the original color scheme, you must still submit an Architectural Change Request to ensure the colors being used are of an original approved pallet.

Upon review of your plans by the Committee, you will receive written notice of their approval, rejection or conditional approval.

Painting is not to begin until written approval of your plans is received.

PER THE GOVERNING DOCUMENTS AND NRS 116, IT COULD TAKE UP TO FORTY-FIVE (45) DAYS FOR AN APPROVAL / DENIAL TO BE GRANTED. TO AVOID CONSTRUCTION DELAYS, PLEASE ENSURE FORMS AND PLANS ARE COMPLETE PRIOR TO SUBMITTAL. ANY INCOMPLETE SUBMITTALS WILL BE RETURNED.

Changes made without submitting an application and receiving prior approval will be in violation of the associations Governing Documents and assessed fines.

INDEMNITY AGREEMENT

CONTRACTOR (identified below) has been hired by Owner to affect the improvements.

CONSTRUCTION of the improvements is subject to the Declaration of Covenants, Conditions, and Restrictions for Coventry Homes at Anthem Community Association, Inc., as well as certain Rules and Regulations of the Coventry Homes at Anthem Community Association, Inc. and/or Architectural Review Committee.

THE ASSOCIATION and the ARC may (but are not obligated to) exercise supervisory responsibility with respect to ascertaining that Contractor's operations and improvements comply with the Rules and Regulations, Design Guidelines and CC&Rs.

CERTAIN INDEMNITIES are required of the Owner and Contractor, as follows, prior to commencement of construction of any improvements.

ACCORDINGLY, OWNER AND CONTRACTOR hereby agree to construct the improvements in accordance with the Rules and Regulations, Design Guidelines and Declaration of Covenants, Conditions and Restrictions of Coventry Homes at Anthem Community Association, Inc.

OWNER shall be responsible for the conduct of Contractors, its employees and agents within Coventry Homes at Anthem Community Association, Inc. Owner and Contractor understand and agree that violations of the Rules and Regulations may be met with a warning, stop work order, lien assessments, and/or revocation of Contractor's right to enter the property.

OWNER AND CONTRACTOR hereby indemnify Coventry Homes at Anthem Community Association, Inc. and the Architectural Review Committee, and agents thereof, and hold them harmless against and from any and all liabilities, claims, losses, damages and expenses connected with the improvements or construction of the improvements.
